## Contextualization<sup>1</sup>

HI has been operating in South Sudan since 2006, implementing emergency and development actions aimed at improving protection, quality of life, and the promotion of rights of vulnerable individuals, including people with disabilities. The operational context in South Sudan today is considered largely humanitarian/emergency while phasing in resilience programming.

Under the responsibility of the Country Director, in collaboration with the country coordination services and based in Juba, the Logistics Manager contributes to the implementation of the mandate and the 10-year global strategy of Humanity & Inclusion. The Logistics Manager ensures the efficient management of logistical resources for the country for South Sudan. S/he is the point person for the Country Director, and as such informs him/her of any problems and suggests solutions within his/her scope of responsibility. S/he is a key player in the rollout and implementation of HI's logistics standards, consisting in a reworking of the positioning of logistics at HI and the assertion of the principle of the professional channel.
