Job Purpose:

The purpose of the Health & Nutrition Officer is to implement project activities geared towards achieving Health and nutrition programme objectives of reducing morbidity and mortality through

the provision of essential health and nutrition services in any of the states of South.

**Key Responsibilities** 

## ERT assessments and interventions:

Work alongside Health & Nutrition Managers in planning, preparation, and implementation of emergency

Work alongside Health & Nutrition Managers in planning, preparation, and implementation of emergency response interventions including provision of primary health care services including CMAM programming (TSFP, OTP, SC), disease outbreak case management, reactive mass vaccination campaigns, MIYCN and the community out-reach component activities.

Responsible for all health and nutrition technical aspects for interventions and ensuring that implementation meets all national and international standards.

Ensuring all financial and logistical policies and procedures are followed.

# **Medical / Technical (ERT interventions)**

- Oversee the provision of primary healthcare provision and supervise the clinical management of patients according to the South Sudan MoH treatment guidelines and international standards.
- Carry out supportive supervision inclusive of developing supervision reports Ensure timely and accurate data collection and reporting including daily and monthly consumption reporting.
- Discuss patients that require referral to other treatment centres with the Health Manager or Medical Manager, including ensuring the accurate documentation of all referrals.
- Identify healthcare workers training needs and support capacity building their capacity building.
- Implement all activities necessary in CMAM program including TSFP, OTP, SC, MIYCN and the community out-reach component activities.
- Responsible for conducting on-the-job training and supportive supervision of locally recruited staff, at PHC facilities, vaccination campaigns and other emergency response settings, ensuring all relevant MoH and Medair guidelines are available and followed.
- Provide training on, supervise, and oversee facility and community-based screening for malnutrition in children (6-59 months), pregnant and lactating women.
- Give feedback to the Health and Nutrition Manager on technical issues related to management e.g., diagnosis, treatment, management of common communicable diseases, etc.
- Responsible for clinic/intervention data collection and report writing at clinic/field level and contribution to ERT assessment and intervention reports.

# Quality Management and beneficiary Accountability

- Fully responsible to continuously monitor progress against set objectives.
- Fully responsible to ensure that all reporting and administration is done according to the relevant guidelines
- Undertake weekly site supervision exercise using the national CMAM Monitoring and Supervision Checklist, track the identify gaps (creation of a logbook which will show the improvement of the findings) provide feedback to the implementation team and devise mechanisms to address identified gaps
- Ensure proper documentation is in place and being used with regards to therapeutic ration and other Gifts in Kinds given to nutrition programme beneficiaries.
- Report any identified fraud cases at site level to the Health and Nutrition Manager



Assist to supervising of locally recruited staff working in the health and nutrition facilities and on ERT Health and Nutrition interventions such as vaccination campaigns and community nutrition screening.
