# I. Presentation of organisation:

### Goal / Purpose:

- The Monitoring, Evaluation, Accountability and Learning (MEAL) Supervisor, under the supervision of the Field coordinator and functionality of the MEAL manager, support the MEAL manager to provide methodological and technical support to teams to ensure the quality of MEAL tools in projects and programmes, thus working within the framework established by the MEAL department.
- As he/she is the focal point for collection and documentation of monitoring and evaluation information.
   Supports the programme teams through monitoring, data collection, data processing, mapping, and analysis of the information as required, that's ensures that MEAL approaches, methods, tools are relevant and consistent across SI programmes and partner organisations, and he/she helps plan and implement activities requiring specific MEAL expertise.
- He/she provides technical support and training to the field staffs in charge of data management and monitoring, participates to the roll out of the accountability framework and contributes to internal knowledge building.

### II. Responsibilities and Tasks:

## Monitoring and evaluation

- Support in the developing and implementing monitoring plans that are consistent with the organization's orientations for projects.
- Contribute to the revision of monitoring and evaluation tools and train program team on design and proper use of these tools, while ensuring SI procedures are respected.
- Participate in data analysis and writing of monitoring and evaluation reports, thus ensures ethical
  principles related to MEAL are respected, especially those concerning gender equality, fairness and "do



no harm". Protects confidential data, applies the principles of informed consent, processing, analysis, and use of MEAL data.

- Contribute to ensuring the quality of implemented WASH project through reporting follow up, results monitoring, context monitoring, lessons learned and knowledge management, tools development and trainings
- Ensure that the activities are meeting qualitative standards and proposal expectations
- Together with the deputy Program Manager, set objectives and specific and general indicators in order to assess and monitor the impact of the programs and to reshape them if necessary.
- Ensure that all required COVID-19 prevention measures are understood and followed by SI staff, daily workers, activity participants, and others.

## Accountability

- Support to establish, implement and monitor the beneficiary Feedback Complaint and Response Mechanism (FCRM) for programme in line with SI standard beneficiary FCRM procedures, including receiving, documenting and managing complaints through feedback sessions, in writing and in person.
- Supervise and support the Feedback, Complaint and Response Mechanisms Assistant (FCRM-Assistant)

 In relationship with teams in charge of database management on the bases, centralize and organize all data on program.
